Congratulations and welcome to ASEICA! We are pleased that your child will be entering the international section for the school year 2019-2020. Our international section student community now consists of nearly 1,800 students in which there are over 40 nationalities represented.

ASEICA is a non-profit association and as an accredited educational partner of the French Education Ministry, we remain committed to providing a bilingual and bicultural education to prepare our students not only for the "Option Internationale du Baccalauréat" (OIB), but for their future as global citizens. In accordance with the texts published by the French Ministry, ASEICA teachers teach literature in the language of the section. Our History-Geography teachers adapt the French syllabus to emphasize the history and geography of the section country.

#### **About ASEICA:**

ASEICA teachers are currently present in two primary schools (École Sartoux in Sophia Antipolis and École Trois Collines in Mougins), four middle schools (Collège Niki de Saint Phalle and Collège International de Valbonne in Valbonne, Collège l'Éganaude in Biot and Collège Cesar in Roquefort les Pins) and one high school (Lycée International de Valbonne).

Each parent is a member of the association, as well as all ASEICA employees. The association is directed by a board of 9 to 11 parent volunteers who meet monthly to address topics that vary from setting the association's budget and defining its policies to planning and organizing events to enrich the section experience.

Volunteers are a vital part of achieving our goals for the international section. Very little can happen without the enthusiasm and participation of parent volunteers, so we hope you will make the most of your membership and join us for:

- Volunteer meetings that are regularly held proceeding the monthly board meeting, occasional committee meetings and in primary school -IPSC (Int'l Primary Social Committee)
- The annual General Assembly Meeting in November
- Events: The International Picnic, International Day, coffee mornings, Galette/Summer camps info evening, Alumni evening, Brevet and OIB ceremonies and more...

ASEICA is fortunate to have energetic and dedicated teachers who not only support the intellectual development of our students, but also take on programs and activities that enrich the overall international section experience.

- Tech Crew Lycée extracurricular
  - > Students learn about and engage in technical aspects of sound and lighting, as well as designing creative sets for various performances.
- Model United Nations College and Lycée extracurricular
  - > Students learn to structure their opinions and develop public speaking skills as they research a country, take on roles as diplomats to debate and then develop solutions to world problems.
- Yearbook Committee Lycée
  - Student lead the yearbook project as editors, photographers, designers and copy writers.

  - International Speech Contest Students from each college participate upon qualifying in an annual speech contest against representatives from other international schools across the Cote d'Azur
- University Guidance Counseling Lycée
  - ASEICA guidance counselors advise and assist students with the selection and application process to universities abroad
- Trips and Exchanges College and Lycée
  - > Trips –Trips can be proposed by some ASEICA teachers to enhance the pedagogical understanding of subjects studied or for cultural enrichment.
  - Exchanges ASEICA organizes an annual six-week exchange with high schools in Australia and New Zealand and a one-week exchange with a high school in Scotland.

# ASEICA, Association pour le Soutien de l'Enseignement International sur la Côte d'Azur,

is a non-profit association governed by the law of July 1901. Parents registering their child(ren) in the educational programs of ASEICA become members of the association. Tuition fees are entirely allocated to the operating costs related to teaching. Regular payments are required in order for the Association to meet its financial obligations.

- Parents commit themselves firmly and irrevocably to pay all tuition fees for the duration of the tuition in the international Anglophone section of their child (ren) and, if applicable, penalties for late or refused payment.
- Any registration for a fee-paying school trip or any other extracurricular activity organized by ASEICA is subject to full payment of tuition fees remaining due.

#### **TUITION FEES 2019-2020**

**Primary: 2,880€** Collège: 1,840€ Lycée: 2,500€

An **annual membership fee** of 15 euros per family should be added to the registration and tuition fees.

A one-time registration fee of 300 euros must be paid by check for each new student in order to confirm registration. This registration fee is **not refundable** in the event of withdrawal. The check will be cashed from July  $1^{st}$ , 2019

#### **Early departure:**

Once the school year has started, fees must be paid in full. <u>No refund will be made</u> and all tuition remaining due at the time of departure must be paid in full.

In the event of early departure, the family must inform the school and ASEICA in writing.

# **DISCOUNTS**

# 1. Discount on tuition fees:

Applicable only for registration applications received **before May 20, 2019** and if you opt for a one-time payment **by direct debit** of the entire amount, a **2 % discount on the tuition fees applies.** The discount will be calculated automatically at the time of the direct debit and will be indicated on your invoice.

Primary: 57.60€ Collège: 36.80€ Lycée: 50.00€

# 1. Large families\*:

Applicable only for children of the same family and with the same person responsible for payment per family. A discount applies only on the youngest child's tuition fees:

- Three children enrolled with ASEICA: 15 % for the third child
- Four children and more enrolled with ASEICA: 40 % for the fourth child and following children

#### **PAYMENT:**

Tuitions fees are payable <u>in euros only.</u> They are invoiced, due and payable annually by July 10, 2019 (unless paid with an additional fee by 10 monthly direct debits). Invoices will be available on **www.ecoledirecte** in July. We will send you your access codes early July in order to login into your personal account.

To help the association reduces its management costs, direct debit payment is the general rule.

**1. Direct debit** (zone SEPA: EEE countries, Switzerland and Monaco)

# a) Direct debit in one payment of the total amount:

This direct debit is free of charge; and will take place around July 10, 2019.

You benefit from a 2% discount on the tuition fees.

#### b) Ten direct debits:

These direct debits take place on the 10<sup>th</sup> of the month, from July 10, 2019 to April 10, 2019.

A yearly 30 euros fee will be applied to this type of payment.

# Should a direct debit be rejected by your bank:

The rejected amount should be paid by check. A penalty of 30 euros will be applied for any rejected direct debit. If two installments are rejected, direct debits will be suspended and the outstanding amount for the year will become due immediately.

Each new request for payment by direct debit or change of bank account should be notified before the 25<sup>th</sup> of each month, in order to be taken into account for the following direct debit.

# 2. One payment of the total amount by check in euros payable in France to ASEICA:

The check of the <u>total amount must</u> be sent with the registration file and write separately from the 300 euros registration fee. The check is cashable from 1 July 2019. You should add a 50 euros charge. No discount can apply.

# 3. One payment of the total amount by bank transfer in euros:

The transfer of the total amount must be sent by 10 July 2019. Transfer fees are the responsibility of the issuer. No discount can apply.

ASEICA reserves the right to refuse any other payment method.

#### LATE PAYMENT AND/OR REFUSED PAYMENT

A penalty of 30 euros will apply to any payment received after the due date each month until the situation is regularized.

In the same way, a penalty of 30 euros will apply in case of a direct-debit is rejected or a check refused.

The association will take any action deemed necessary to recover unpaid amounts. All bank charges, collection and legal costs incurred are at the debtor's responsibility and will be added to the amount due.

ASEICA reserves the right to take all necessary measures in the case of non-payment of tuition fees, in particular to exclude students from extra-curricular activities and/or from the possibility of benefiting from our university guidance service.
